The Series A 12.0% Cumulative Senior Preferred Stock had a face value of \$1,000 per share and was converted into Common Stock at a conversion price equal to the initial public offering price of \$18 per share, resulting in a conversion of 29,050 shares of Series A 12.0% Cumulative Senior Preferred Stock into 1,613,886 shares of Common Stock.
