The Registrant expects to report a net loss of approximately \$6.4 million or \$1.79 basic and \$1.77 diluted loss per share of common stock for the quarter ended March 31, 2008, compared to net income of approximately \$1.17 million or \$0.32 basic and diluted income per share for the quarter ended March 31, 2007. The net loss of \$6.4 million was driven by a non-cash \$6.0 million impairment charge for the write-off of goodwill associated with Colorado National Bank. During the three months ended March 31, 2008, \$2.6 million in provisions for loan losses was also recorded, compared to approximately \$230,000 during the three months ended March 31, 2007.
