**(a) Amount Beneficially Owned**

As of the date of this filing, each Reporting Person may be deemed to be the beneficial owner of 295,000 shares of Common Stock owned outright by Millenco, L.L.C., a Delaware limited liability company ("Millenco"), formerly known as Millenco, L.P., a Delaware limited partnership, which shares are held as part of the Company's Units ("Units"). Each Unit consists of (1) one share of Common Stock, and (2) two Warrants ("Warrant").

Each Warrant entitles the holder to purchase one share of the Company's Common Stock at a price of \$5.00. Each Warrant will become exercisable on the later of the Company's completion of a business combination and October 11, 2007, and will expire on October 10, 2010, or earlier upon redemption. As of the date of this filing, the Company has not announced the completion of a business combination.

Millennium Management, L.L.C., a Delaware limited liability company ("Millennium Management"), is the manager of Millenco, and consequently may be deemed to have voting control and investment discretion over securities owned by Millenco. Israel A. Englander ("Mr. Englander") is the managing member of Millennium Management. As a result, Mr. Englander may be deemed to be the beneficial owner of any shares deemed to be beneficially owned by Millennium Management. The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the shares owned by Millenco.

Note: Millennium Partners, L.P., a Cayman Islands limited partnership ("Partners"), is a non-managing member of Millenco. As a non-managing member, Partners has no investment or voting control over Millenco or its securities positions.
