(1) Includes a restricted stock award of 3,686 shares effective August 5, 2013. Sale or transfer rights for 1,659 of these shares shall vest with installments of 30% on March 11, 2014, 30% on March 11, 2015, and the remaining 40% on March 11, 2016, provided the grantee is still an employee of Safety Insurance Group, Inc. Sale or transfer rights for the remaining 2,027 shares will vest over a three-year performance period commencing on January 1, 2013 and ending on December 31, 2015. Vesting of these 2,027 shares is dependent upon the attainment of pre-established performance objectives, and any difference between shares granted and shares earned at the end of the performance period will be reported at the conclusion of the performance period in 2016.
