maturing each day. For assuming this obligation, Mr. Pratt received \$9,860,364 as of March 31, 2014. Mr. Pratt has pledged 400,000 shares of PRIM common stock to secure the obligations. He has retained voting rights of the pledged shares.

- (2) On each maturity date, the number of shares delivered to the buyer will be determined as follows: (a) If the settlement price is less than or equal to \$25.6446/share, Mr. Pratt will deliver 10,000 shares; (b) if the settlement price is greater than \$25.6446/share but less than or equal to \$36.8321/share, he will deliver shares equal to the product of 10,000 shares multiplied by \$25.6446 divided by the settlement price; or (c) if the settlement price is greater than \$36.8321/share, he will deliver shares equal to the result of subtracting the quotient of \$111,875 divided by the settlement price from 10,000 shares. For the 4/03/2017 transaction, the settlement price was \$23.03 per share and for the 4/04/2017 transaction the settlement price was \$22.90 per share. Accordingly, 10,000 shares were delivered for each of the two transactions.
