EXPLANATORY NOTE REGARDING THIS AMENDMENT ON FORM 8-K/A

Registrant is filing this Current Report on Form 8-K/A solely for the purpose of making the following revisions to the information reported in Registrant's Current Report on Form 8-K filed on October 6, 2004:

Item 3.02 is revised to report the correct number of warrants to be issued to the investors as 150,000 rather than the amount of 250,000 reported in the original filing due to scrivener's error.

Exhibit 99.1 is revised to reflect the correct subscription amount of a purchaser as \$251,600 which was incorrectly reported as \$250,000 in the original filing.

Item 3.02. Unregistered Sales of Equity Securities.

On October 5, 2004 the Registrant entered into a Securities Purchase Agreement and related agreements with institutional investors. Pursuant to the terms of the Agreement, the Registrant agreed to sell an aggregate of 407,136 shares of its common stock to the investors at a price of \$1.85 per share. The Registrant will also issue Warrants to the investors to purchase an aggregate of 150,000 shares of the Registrant's common stock for a period of five years from the closing, at an exercise price of \$2.30 per share, subject to adjustment.

The Agreement provides that the Registrant will file a registration statement with the U.S. Securities and Exchange Commission covering the resale of the shares by the investors.

The Agreement also provides the investors with the right to participate in future equity financings by the Registrant for a period of 12 months, and restricts the Registrant's ability to issue additional common stock within 30 days of the closing of the transactions contemplated by the Agreement.

The foregoing is not a complete description of the terms of the agreements referred to above. The agreements are filed herewith as Exhibits 99.1 and 99.4.

On October 6, 2004 Registrant issued a press release announcing the entering into the Securities Purchase Agreement, a copy of which is filed herewith as Exhibit 99.5.
