**Item 6. INDEMNIFICATION OF DIRECTORS AND OFFICERS**

Articles 254 of the Commercial Code of Japan (the Commercial Code ) and Article 21-14, Paragraph 7, Item 4 of the Law for Special Exception to the Commercial Code Concerning Audit, etc. of Joint Stock Companies of Japan (the Special Law ) make the provisions of Section 10, Chapter 2, Book III of the Civil Code of Japan applicable to the relationship between the Registrant and its directors and executive officers, respectively. Section 10, among other things, provides in effect that:

(1) Any director or executive officer of a company may demand advance payment of expenses which are considered necessary for the management of the affairs of such company entrusted to him;

(2) If a director or an executive officer of a company has defrayed any expenses which are considered necessary for the management of the affairs of such company entrusted to him, he may demand reimbursement therefor and interest thereon after the date of payment from such company;

(3) If a director or an executive officer has assumed an obligation necessary for the management of the affairs of a company entrusted to him, he may require such company to perform it in his place or, if it is not due, to furnish adequate security; and

(4) If a director or an executive officer, without any fault on his part, sustains damage through the management of the affairs of a company entrusted to him, he may demand compensation therefor from such company.

The Registrant has entered into agreements with its outside directors as defined under the Commercial Code under which, if such directors become liable for damages to the Registrant pursuant to Article 21-17, Paragraph 1 of the Special Law, for any reason attributable to their duties performed in good faith and without gross negligence, such liability is limited to certain amounts. Such limitation is generally enforceable as between the Registrant and such directors under Japanese law. Such agreements may not be available for certain violations of U.S. federal securities law and may be determined by courts of the United States to be unenforceable in such circumstances.
