Attached is an English translation of the summary of the letter dated April 17, 2006 filed by the Company with the *Bolsa de Comercio de Buenos Aires* and the *Comisión Nacional de Valores*.

By letter dated April 17, 2006, the Company reported that a holder of Company's Convertible Notes exercised its conversion right. Hence, the financial indebtedness of the Company shall be reduced in US\$ 35,729 and an increase of 70,360 ordinary shares face value pesos 1 each was made. The conversion was performed according to the terms and conditions established in the prospectus at the conversion rate of 1.96928 shares, face value pesos 1 per Convertible Note of face value US\$ 1. As a result of that conversion, the outstanding shares of the Company goes from 176,199,596 to 176,269,956. On the other hand, the amount of registered Convertible Notes is US\$ 35,623,881.
