**Item 5.03. Amendments to Articles of Incorporation or Bylaws; Change in Fiscal Year.**

On and effective December 13, 2007, the Board of Directors of BJS Wholesale Club, Inc. approved the following amendments to the company's By-laws:

Section 2.6 ( Action by Vote ) was amended to provide that in an uncontested election of directors, a nominee will be elected if the votes cast for such nominee exceed the votes cast against such nominee. In the case of a contested election, directors shall continue to be elected by a plurality of the votes cast.

Section 7 ( Capital Stock ) and Section 8 ( Transfer of Shares of Stock ) were amended to more explicitly address uncertificated shares. The full text of the amendments is included in the exhibit filed herewith and is incorporated herein by reference.
