**Item 8.01 Other Events**

On October 28, 2011, Mathias J. Barton, co-President of Dorman Products, Inc. (the Company), entered into a Rule 10b5-1 trading plan (the Plan) with a broker to manage the sale of up to 25,000 shares of the Company's common stock, subject to the terms and conditions of the Plan. The Plan expires on December 31, 2012, unless renewed, extended, or terminated earlier by Mr. Barton.

Mr. Barton will have no control over the timing of stock sales under the Plan, thereby allowing trades to occur exempt from blackout periods prescribed by the Company's Insider Trading Policy. Any transactions under the Plan will be reported by Mr. Barton through Rule 144 filings and individual Form 4 filings with the Securities and Exchange Commission, as appropriate.

The Plan is intended to satisfy the affirmative defense conditions of Rule 10b5-1 of the Securities Exchange Act of 1934. Rule 10b5-1 allows corporate insiders to establish prearranged written stock plans. A Rule 10b5-1 plan must be entered into in good faith at a time when the insider is not aware of material, nonpublic information.

Mr. Barton has stated that his trading plan is designed to allow him to monetize a portion of his equity position in a systematic, nondiscretionary manner with the goal of minimal market impact and compliance with regulations adopted by the Securities and Exchange Commission.
