(d) On July 14, 2016, James W. Breyer was appointed to the board of directors of Blackstone Group Management L.L.C., the general partner (the "General Partner") of The Blackstone Group L.P. (the "Partnership"), and its Audit and Conflicts Committees.

Mr. Breyer will receive an annual cash retainer of \$150,000. In addition, Mr. Breyer received upon his appointment a grant of deferred restricted common units with a value of \$150,000 under The Blackstone Group L.P. Amended and Restated 2007 Equity Incentive Plan. These deferred restricted common units will vest, and the underlying common units will be delivered, on the first anniversary of the date of grant, subject to Mr. Breyer's continued service on the board of directors of the General Partner.
