On August 31, 2016, pursuant to its terms, the Restructuring Support and Forbearance Agreement, dated as of July 31, 2016, among Caesars Entertainment Corporation (<u>CE</u>C), Caesars Entertainment Operating Company, Inc., a majority owned subsidiary of CEC (<u>CEO</u>C), and holders of a significant amount of claims (<u>Second Lien Bond Claims</u>) in respect of CEOC s 12.75% Second-Priority Senior Secured Notes due 2018, 10.00% Second-Priority Senior Secured Notes due 2018 and 10.00% Second-Priority Senior Secured Notes due 2015 (the <u>Second Lien Bond RSA</u>), expired and did not become effective. Notwithstanding the expiration of the Second Lien Bond RSA, CEC and CEOC will continue to engage in negotiations with holders of Second Lien Bond Claims on the terms of a consensual plan of reorganization for CEOC.
