The option is vested as to 18,000 shares on the date of grant. With respect to the remaining 6,000 shares underlying the option, the option (1) will vest with respect to 2,000 shares on each of October 31, 2006, November 30, 2006, and December 31, 2006. Vesting with respect to the remaining shares underlying the option stops if Grantee ceases to service on the Science Committee of the Board.

The reporting person agreed to cancellation of an option granted to him on February 1, 2006, in exchange for a new option under the 2007 (2) Long-Term Incentive Plan. The new option is on substantially the same terms as the cancelled option, including as to number of underlying shares, exercise price, vesting schedule, and expiration date.
