(BM&FBOVESPA: GOLL4 and NYSE: GOL), (S&P: B-, Fitch: B-, Moody's: B3), the largest low-cost and best-fare airline in Latin America, hereby announces its preliminary air traffic figures for November and the year to date (11M15). Comparisons refer to the same periods in 2014.

GOL Highlights

| GOL reduced its **domestic supply** by **3.4%** in November and reaffirmed its previous 4Q15 national market supply projection of a decline of between **5** and **7%**.

| **Domestic demand** fell by **10.9%** in the month, giving a **load factor** of **73.6%**, **6.3 p.p.** down on November 2014.

| **International market** capacity declined by **12.0%** in November, while demand fell by **11.1%**, leading to a load factor of **69.9%**, **0.7 p.p.** higher than in the same month last year.

| GOL **transported 3.0 million passengers** in the month, **12.8%** down on November 2014, and **35.4 million** year-to-date, **1.6%** less than in the same period last year.
