#### Item 2.02 Results of Operations and Financial Condition.

On October 6, 2008, STAAR Surgical Company (the "Company") published a press release reporting selected preliminary sales data for the quarter ended September 26, 2008 (the "Press Release"), a copy of which is attached to this Report as Exhibit 99.1 and is incorporated herein by this reference.

The Press Release reported that the Company's sales of its Visian ICL(R) refractive implant during the quarter increased by 52% over the comparable period of 2007 and that U.S. sales of the Visian ICL during the quarter increased by 25% over the comparable period of 2007.
