As of the close of business on March 15, 2017, the reporting persons and affiliates of the reporting persons beneficially owned an aggregate of 4,330,971 shares or 5.0% of the Issuer's Common Stock outstanding.

However, as of the close of business on March 23, 2017, Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), beneficially owned 2,695,415 shares of the Issuer's Common Stock and Integrated Assets II LLC, a Delaware limited liability company ("Integrated Assets II"), beneficially owned 687,094 shares of the Issuer's Common Stock, which collectively represented 3,382,509 shares or 3.9% of the Issuer's Common Stock outstanding.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies and Integrated Assets II and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and Integrated Assets II.

Israel A. Englander, a United States citizen ("Mr. Englander"), is the managing member of Millennium Management. Consequently, Mr. Englander may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and Integrated Assets II.

The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies or Integrated Assets II.

(b) Percent of Class:

As of the close of business on March 23, 2017, Millennium Management and Mr. Englander may be deemed to have beneficially owned 3,382,509 shares or 3.9% of the Issuer's Common Stock outstanding (see Item 4(a) above), which percentage was calculated based on 86,435,842 shares of Common Stock outstanding as of March 7, 2017, as per the information contained in the Issuer's Form 8-K dated March 7, 2017 and the Issuer's Prospectus Supplement dated March 2, 2017.
