## Edgar Filing: Karczmer Aaron - Form 4

Represents shares earned in respect to performance-based restricted stock units (PBRsUs) based on the achievement by PayPal of certain performance targets for the 2018 performance period, which were vested as shares of common stock on 2/15/2019.

Upon vesting, the reporting person will receive a number of shares of common stock equal to the number of restricted stock units that have vested.
