- On March 28, 2007, Mr. Kish was granted Stock Appreciation Rights (SARS) with respect to a total of 12,000 shares of common stock.
- (1) The grant price for the SARS is \$22.96 per share of common stock. The SARS will vest 25% per year on the first of four anniversary dates from the date of grant and expire on March 28, 2014.
