As of December 31, 2004, 256,215 shares of Common Stock, or 1.1% of the total outstanding shares of Common Stock on that date, were held by KSC L.P. and 544,457 shares of Common Stock, or 2.2% of the total outstanding shares of Common Stock on that date, were held by KSC Ltd.

KSC L.P. may be deemed to have shared voting and dispositive power over the 256,215 shares of Common Stock it owns, or 1.1% of the total outstanding shares of Common Stock. KSC Ltd. may be deemed to have shared voting and dispositive power over the 544,457 shares of Common Stock it owns, or 2.2% of the total outstanding shares of Common Stock.

Because KSA is the general partner of KSC L.P., pursuant to Rule 13d-1, as of December 31, 2004, KSA may be deemed to be the beneficial owner of 256,215 shares of Common Stock, or 1.1% of the total outstanding shares of Common Stock
