The name of the issuer is AZZ incorporated (the "Company").

- (iii) Tontine Overseas Associates, L.L.C., a limited liability company organized under the laws of the State of Delaware ("TOA"), which serves as investment manager to Tontine Capital Overseas Master Fund, L.P., a Cayman Islands exempted limited partnership ("TCO") with respect to the shares of Common Stock owned by TCO; and
- (iv) Jeffrey L. Gendell ("Mr. Gendell"), with respect to the shares of Common Stock owned directly by TCP and TCO.
