TURK TELEKOM INITIATED LAWSUIT AGAINST TURKCELL

We have been notified today that Turk Telekom has initiated a lawsuit at Ankara 7th Court of First Instance claiming that, Turkcell has financially damaged Turk Telekom because of the interconnection agreement signed with Milleni.com and requested collection of its damages totaling to TRY450.9 million (equivalent to US\$329.7 million as of August 19, 2005) and requested temporary injunction.

Turkcell believes that such a request has no legal basis since Turkcell conducted these operations based on the permissions received from Ministry of Transportation in order to assure international interconnection via Milleni.com. Turkcell will take all necessary legal actions regarding this issue.

We hereby confirm that the above-mentioned explanations are furnished as per the provisions of the Communiqué Serial no VIII/39, that they reflect all information we have gathered so far, that they are in accordance with our corporate documents, that we have used all endeavours to collect the complete and true related information and that we assume the responsibility for this disclosure.
