**TELECOM ITALIA: SALE OF 40.5% STAKE IN AVEA TO TURK TELEKOM FOR 500 MILLION DOLLARS FINALISED**

**Telecom Italia has reinvested USD 250 million in the capital of Oger Telecom, reinforcing its participation in the holding which controls Turk Telekom**

*Milan, 18 September 2006* Telecom Italia announces that, having received authorisation from the relevant Turkish authorities, the sale of 40.5% stake in the mobile operator Avea, held by subsidiary TIM International, to Turk Telekom, for a total of USD 500 million, has been finalised.

Furthermore, as foreseen in the agreement announced on the 14 July, today, Telecom Italia has, at the same time, reinvested USD 250 million in the capital of Oger Telecom, the holding which controls Turk Telekom.

- the ability of the Telecom Italia Group to successfully implement its reorganization;

- the success of Telecom Italia's customer loyalty and retention programs and the impact of such programs on revenues;

- the impact of regulatory decisions and changes in the regulatory environment, including implementation of recently adopted EU directives in Italy;

- the impact of economic development generally on the international business of the Telecom Italia Group and on its foreign investments and capital expenditures;
