(1) Shares were acquired pursuant to a restricted stock grant under the Corporation's 2005 Stock Plan for Non-employee Directors.

Shares were issued pursuant to the Company's Non-Employee Director Compensation Plan in which newly elected non-employee directors receive an initial grant of restricted stock in the amount of \$35,000 for service on the board. The restrictions on these shares lapse upon the shorter of (a) five years from the date of grant or (b) until such time as the service of the recipient as a Non-employee Director of the Company shall have ended by reason of his or her (i) death or disability or (ii) failure to be reelected.

(3) Price is based on the closing market price for the securities on the New York Stock Exchange as of February 6, 2012.

Shares were issued pursuant to the Company's 2005 Non-Employee Director Compensation Plan in which non-employee directors receive an annual grant of restricted stock in the amount of \$70,000 for service on the board. The restrictions on these shares lapse upon the shorter of (a) three years from the date of grant or (b) until such time as the service of the recipient as a Non-employee Director of the Company shall have ended by reason of his or her (i) death or disability or (ii) failure to be reelected.

(5) Price is based on the closing market price for the securities on the New York Stock Exchange as of February 7, 2012.
