As discussed in previous filings with the Securities and Exchange Commission, on February 12, 2009, the Registrant completed the first interim efficacy analysis of its Riquent® Phase 3 ASPEN Study and determined that continuing the study was futile. As a result, the Registrant has discontinued all research, development and clinical activities and has terminated substantially all of its workforce. Accordingly, the Registrant's operating expenses for the three and six months ended June 30, 2010 are expected to be substantially lower than reported for the three and six months ended June 30, 2009. Operating expenses for the three and six months ended June 30, 2010 are expected to be less than \$1.0 million and less than \$2.7 million, respectively, compared to \$2.0 million and \$14.4 million, respectively, for the three and six months ended June 30, 2009. As a result of recording the value of financial instruments issued in conjunction with the May 2010 financing, net loss for the three months ended June 30, 2010 is expected to be higher than the net loss for the three months ended June 30, 2010 is expected to be less than \$3.5 million compared to a net loss for the three months ended June 30, 2009 of \$2.0 million. Net loss for the six months ended June 30, 2010 is expected to be less than \$5.2 million compared to a net loss for the six months ended June 30, 2009 of \$6.3 million.

Details related to the May 2010 financing were disclosed in a Form 8-K filed with the Securities and Exchange Commission on May 28, 2010.
