(1) On September 30, 2002, Yellow Corporation distributed to its shareholders of record all of the outstanding common stock of SCS Transportation, Inc. In lieu of receiving shares of SCS, the reporting person received additional restricted shares of Yellow Corporation. The number of shares of restricted stock of Yellow Corporation reported above compensate such reporting person for the SCST shares such person would have otherwise received in the distribution.
