The Shares are being registered to permit public secondary trading of the shares that are being offered by the selling shareholders named in the prospectus. We are not selling any of the Shares in this offering and therefore will not receive any proceeds from this offering.

Our common stock is traded on the Over-the-Counter Bulletin Board under the symbol "NEOP".
