- On October 16, 2017, pursuant to the Merger and Sponsorship Transaction Agreement, dated as of March 6, 2017 (the "Transaction Agreement"), by and among the Issuer, Orion US Holdings 1 L.P. and BRE TERP Holdings Inc. ("Merger Sub"), a Delaware corporation and wholly-owned subsidiary of Orion US Holdings 1 L.P., Merger Sub merged with and into the Issuer (the "Merger"), with the Issuer continuing as the surviving corporation in the Merger. Immediately following the consummation of the Merger, Orion US Holdings 1 L.P. held 51% of the shares of Class A common stock, par value \$0.01 per share, of the Issuer (the "Class A Shares"). In connection with the consummation of the Merger, Orion US Holdings 1 L.P. acquired 65,144,459 Class A Shares at a price of \$9.52 per share.
- Further, each holder of Class A Shares, restricted stock awards and restricted stock units of the Issuer outstanding immediately prior to

 (5) the effective time of the Merger received a special cash dividend paid by the Issuer in the amount of \$1.94 per Class A Share or restricted stock award held or Class A Share into which such restricted stock units were exchangeable.
