("SCMF II"), Saba Capital Leveraged Master Fund Ltd. ("SCLMF"), Saba Capital Series LLC Series 1 ("SCS"), Saba Capital CEF Opportunities 1, Ltd. ("SCEF1"), Saba Capital CEF Opportunities 2, Ltd. ("SCEF2") and Saba Closed-End Funds ETF (CEFS).
