On March 18, 2019, Array BioPharma Inc. issued a press release announcing that the National Comprehensive Cancer Network<sup>®</sup> (NCCN<sup>®</sup>) has updated the Clinical Practice Guidelines in Oncology for Colon and Rectal Cancer to include BRAFTOVI<sup>®</sup> in combination with MEKTOVI<sup>®</sup> and cetuximab or panitumumab as a Category 2a treatment for patients with BRAF<sup>V600E</sup>-mutant metastatic colorectal cancer (mCRC), after failure of one to two prior lines of therapy for metastatic disease.
