

**Item 7.01 Regulation FD Disclosure**

Set forth below is a summary of the tax allocation of the distributions paid by Inland Western Retail Real Estate Trust, Inc. (the Company) on its common shares during 2011. Stockholders receiving distributions in 2011 will receive a Form 1099-DIV summarizing the allocation of the 2011 distributions. Therefore, the tax allocation provided in this report is for informational purposes only. Stockholders are advised to consult with their tax advisors about the specific tax treatment of distributions paid by the Company in 2011.

The fourth quarter 2011 distribution with a record date of December 31, 2011 and payment date of January 10, 2012 is taxable in 2012, and not reflected in the 2011 tax allocation. The following table, presented on a per share basis, summarizes the tax allocation determined by the Company.
