EXPLANATORY STATEMENT

This Amendment No. 10 to Schedule 13D (Amendment) relates to the Common Stock, Par Value \$0.01 per share (the Common Stock) of AutoNation, Inc. (the Issuer). Cascade Investment, L.L.C. (Cascade), Bill & Melinda Gates Foundation Trust (the Trust), William H. Gates III and Melinda French Gates (collectively, the Reporting Persons), jointly file this Amendment to amend and supplement the Items set forth below of the Reporting Persons Schedule 13D previously filed with the Securities and Exchange Commission on February 5, 2009, as amended on February 6, 2009, February 24, 2010, July 23, 2010, August 17, 2010, February 2, 2011, November 4, 2011, November 14, 2011, December 2, 2011, and February 17, 2012. Neither the present filing nor anything contained herein shall be construed as an admission that the Reporting Persons constitute a group for any purpose and the Reporting Persons expressly disclaim membership in a group.

Item 2. Identity and Background
