**Item 7.01. Regulation FD Disclosure.**

On May 7, 2012, Thompson Creek Metals Company Inc. (the "Company") entered into an underwriting agreement with J.P. Morgan Securities LLC, as representative for the several underwriters named therein (collectively, the "tMEDS Underwriters") providing for the offer and sale in a firm commitment offering of 8,800,000 tMEDS, sold by the Company for a stated amount of \$25 (\$24.25 per tMEDS, net of underwriting discounts) and an option to purchase up to 1,200,000 additional tMEDS to cover over-allotments (the "Over-Allotment Option"). On May 16, 2012, the tMEDS Underwriters notified the Company that the tMEDS Underwriters do not intend to exercise the Over-Allotment Option.
