The restricted stock units were granted on March 24, 2010 as part of the Issuer's annual equity grant to executive officers. These units are (6) scheduled to vest annually at a rate of 20% on each of the first three anniversaries of the grant date, with the remaining 40% scheduled to vest on the fourth anniversary of the grant date.
