SISOPs vest three years after the date of grant subject to accelerated vesting upon certain events. Unvested SISOPs are subject to forfeiture if certain stock ownership targets are not met. Vested SISOPs are automatically payable in an equal number of shares of PG&E Corporation common stock following termination of employment.

- Represents the approximate number of shares of PG&E Corporation common stock held for the reporting person in the PG&E Corporation Retirement Savings Plan (RSP). These holdings have been trued up to conform to the RSP balance at May 9, 2014, and reflect the acquisition of approximately 49.12 shares on 4/15/14 due to dividend reinvestment.
