- (1) Each unit of phantom stock is the economic equivalent of one share of Johnson Controls common stock.  
The phantom stock units accrue under the Johnson Controls Directors' Deferred Compensation Plan and settled 100% in cash upon the reporting person's retirement. The reporting person has the right to transfer the value of the phantom stock account into an alternative investment account within the plan.
- (2) The balance includes 516,260 phantom stock units acquired via dividend reinvestment on April 2, July 2 and October 2, 2014 and January 5, 2015, at prices ranging from \$44.68 to \$50.92 per unit.
