The actual sale price for the shares was: 300 shares at \$6.26; 500 shares at \$6.28; 200 shares at \$6.31; 200 shares at \$6.34; 106 shares at \$6.35; 1,494 shares at \$6.36; 700 shares at \$6.37; 783 shares at \$6.38; 3,236 shares at \$6.39; 2,221 shares at \$6.40; 100 shares at \$6.4025; 1,960 shares at \$6.41; 400 shares at \$6.42; 300 shares at \$6.43.
- (2) The options are exercisable as they vest. A total of 25% of the entire number of shares subject to this stock option becomes vested and
- (3) fully exercisable on the first anniversary of the vesting commencement date and the remaining shares subject to this stock option vest and become exercisable in equal monthly installments, ratably over the following 36 months.
