- (2) A total of 12,500 shares were sold pursuant to a 10b5-1 Plan, at an average sale price of \$6.2299 per share. The actual sale price for the shares was: 403 shares at \$6.16; 897 shares at \$6.17; 500 shares at \$6.18; 100 shares at \$6.19; 400 shares at \$6.20; 100 shares at \$6.21; 1,800 shares at \$6.22; 100 shares at \$6.2250; 2,682 shares at \$6.23; 100 shares at \$6.2325; 200 shares at \$6.2350; 1,600 shares at \$6.24; 1,533 shares at \$6.25; 616 shares at \$6.26; 899 shares at \$6.27; 170 shares \$6.28; 100 shares at \$6.30; 200 shares at \$6.31; 100 shares at \$6.32.

A total of 25% of the entire number of shares subject to this stock option becomes vested and fully exercisable on the first anniversary of the vesting commencement date and the remaining shares subject to this stock option vest and become exercisable in equal monthly installments, ratably over the following 36 months.
