(1) A total of 6,000 shares were sold pursuant to a 10b-5-1 Plan at an average sale price of \$6.648297 per share. The actual sale price for the shares was: 910 shares at \$6.58; 90 shares at \$6.64; 1,000 shares at \$6.58; 927 shares at \$6.64; 2,000 shares at \$6.69; 1,073 shares at \$6.70.

(2) The options are exercisable as they vest.
