(1) On August 1, 2011, the issuer issued 3,312 shares of common stock to the reporting person in a settlement conversion of a performance share award (the "PSA") reported in a Form 4 for the reporting person filed on July 29, 2011. The PSA represented the right to receive,

Each restricted stock unit represents a contingent right to receive one share of stock. The restricted stock unit grants vests as follows: 433 (2) shares on 8/1/10, 864 shares on 8/1/11 and 1,728 shares on 8/1/12. The vested shares will be issued to the reporting person on the vesting dates, at which time all restrictions on the vested shares will lapse.
