- (1) 779 Restricted Stock Units (Common Stock equivalents) were granted pursuant to the WD-40 Company 2007 Stock Incentive Plan. The Restricted Stock Units (RSUs) will be settled solely with Issuer Common Stock upon an annual vesting schedule as provided for in the Award Agreement for the RSUs as follows: 34% not later than November 15, 2016, 33% not later than November 15, 2017, and 33% not later than November 15, 2018.
- (2) 779 Market Share Units (Common Stock equivalents) were granted pursuant to the 2007 Stock Incentive Plan. The Market Share Units (MSUs) will be settled solely with Issuer Common Stock upon performance vesting as provided for in the Award Agreement for the MSUs following a 3-year performance measurement period.
- (3) Acquisition of Market Share Units (Common Stock equivalents) upon certified performance vesting of Market Share Units (MSUs) awarded to the reporting person on October 25, 2012. A total of 1,954 vested shares will be issued to the reporting person pursuant to the MSU Award Agreement, subject to withholding for taxes.
- (4) Total includes 975.073 shares held in WD-40 Company Profit Sharing Plan (Company Stock Fund) account. Total also includes 1,605 Restricted Stock Units, all of which are subject to future vesting and 4,261 Market Share Units, of which 2,307 are subject to future
