  - (1) Includes 4,000 Restricted Stock Units (previously awarded on March 6, 2006) which will vest on the third anniversary of the date of grant, subject to potential accelerated vesting in specified circumstances. Upon vesting, each restricted stock unit will represent the right to receive one Class A Subordinated Voting Share of the Issuer.
  - (2) Stock Appreciation Rights (previously granted on July 30, 2004) vest 1/3 on each anniversary of the grant date, expire four years from the grant date, and may be settled in cash.
  - (3) Canadian dollars.
  - (4) Stock Options of the Issuer (granted on June 11, 2003) vest 1/5 on grant, and 1/5 on each anniversary of the grant date, expiring five (5) years from the grant date.
    - (5) Stock Options of the Issuer granted on April 28, 2006 vest over five (5) years from the grant date: 20% (5,000 options) on the first anniversary of the grant date and an additional 20% on each of the next four (4) succeeding anniversaries of the grant date, expiring ten (10) years from the grant date.
  - (6) These Class A Share Purchase Warrants form part of the Units issued by MDC Partners Inc.
