During the first quarter of 2015, benefiting from the factors such as low international crude oil prices and continual adjustments in China's economic structure, demand from aviation market was huge; the Company continuously improved its operating abilities; as market organisation and support during the Spring Festival travel season were strong, both the flight capacity and the number of passengers carried during the Spring Festival travel season reached a historical new high.
