TENDER OFFER FOR GOLD FROST SHARES

YAVNE, ISRAEL - JUNE 22, 2009 - G. WILLI-FOOD INTERNATIONAL LTD. (NASDAQ: WILC) (the "COMPANY" or "WILLI FOOD"), announces that it has today commenced a tender offer to purchase from the holders of shares and/or depositary interests of Gold Frost Ltd. ("GOLD FROST") all of the issued and outstanding share capital of Gold Frost not already held by G. Willi Food for a price of 7 pence per share or per depositary interest in cash.

Gold Frost was admitted to the AIM market of the London Stock Exchange ("AIM") on 9 March 2006. On 28 May 2008, following a resolution of the shareholders of Gold Frost, the AIM admission was cancelled. As stated in the admission document relating to the admission of Gold Frost to AIM, transactions in Gold Frost shares and depositary interests are not subject to the provisions of the UK Takeover Code and accordingly the protections provided to shareholders under the UK Takeover Code are not available to holders of Gold Frost shares and depositary interests.

The tender offer is subject to the condition that the number of shares and depositary interests duly tendered constitute, upon expiration of the Offer Period (as defined below) and together with the shares held by Willi Food at such time, more than 95 per cent of the issued and outstanding share capital of Gold Frost. Willi Food currently holds approximately 89.99 per cent of the issued and outstanding share capital of Gold Frost. If the tender offer is completed, Willi Food expects to pay an aggregate amount of approximately (pound)370,430 for all the shares and depositary interests (including those not tendered in the tender offer).

The tender offer will expire on July 22, 2009, at 3:00 pm London time (the "OFFER PERIOD"). If upon expiration of the Offer Period the number of Gold Frost shares and depositary interests tendered pursuant to the tender offer, together with the Gold Frost shares and depositary interests held by Willi Food, exceeds 95 per cent of Gold Frost's issued and outstanding share capital, Willi Food will purchase all of the issued and outstanding Gold Frost shares and depositary interests currently not owned by it (including those not tendered in the tender offer) at the tender offer price. If upon expiration of the Offer Period Willi Food will hold 95 per cent or less of the issued and outstanding share capital

of Gold Frost, the offer will be null and void, and Willi Food will not purchase any of the tendered Gold Frost shares or depositary interests.
