THAT 012 SMILE RECEIVED A LAWSUIT AND A
MOTION FOR THE RECOGNITION OF THIS LAWSUIT
AS A CLASS ACTION

ROSH HA'AYIN, Israel, December 21, 2011 - Partner Communications Company Ltd. ("Partner" or "the Company") (NASDAQ and TASE: PTNR), a leading Israeli communications operator, announces today that its fully owned subsidiary, 012 Smile Telecom Ltd. ("012 Smile"), was served with a lawsuit and a motion for the recognition of this lawsuit as a class action, filed against 012 Smile on November 24, 2011 in the Haifa District Court.

The claim alleges that 012 Smile did not comply with the requirements of the Israeli Consumer Protection Law regarding a transaction for a determinate period and a continuous transaction.

If the lawsuit is recognized as a class action, the total amount claimed against 012 Smile is estimated by the plaintiff to be approximately NIS 467 million. The claim further alleges that the group members suffered non pecuniary damage as a result of harm to the autonomous will and that the estimation of this damage shall be determined in accordance with the court's discretion.

012 Smile is reviewing and assessing the lawsuit and 012 Smile and Partner are unable, at this preliminary stage, to evaluate, with any degree of certainty, the probability of success of the lawsuit or the range of potential exposure, if any.
