## SCHEDULE 13D/A

This Amendment No. 3 to the Statement on Schedule 13D (this "Statement") is being filed by the undersigned to amend the schedule 13D (the "Schedule 13D") which was originally filed on November 28, 2008, as amended and supplemented by Amendment No. 1 thereto filed on March 5, 2009 and by Amendment No. 2 thereto filed on June 13, 2018 relates to the ordinary shares, nominal value 0.01 New Israeli Shekels per share (the "Ordinary Shares"), of Silicom Limited, a company organized under the laws of Israel (the "Issuer"). The address of the principal executive offices of the Issuer is 8 Hanagar Street, Kfar Saba Industrial Park, Kfar Saba 44000, Israel.

## Interest in Securities of the Issuer.

## Item 5.

Item 5 of the Statement is hereby amended and restated in its entirety as follows:

- The disclosure under Item 3 and Items 11 and 13 of the cover are incorporated herein by reference. The Reporting Person beneficially owns approximately 1,209,294 Ordinary Shares, or 16.02%, of the Company's total number of (a) Ordinary Shares that the Company advised were issued and outstanding as of March 31, 2018. Of such shares (i) 887,343 Ordinary Shares are held by the Reporting Person; and (ii) 321,951 Ordinary Shares are held of record by Lomsha Ltd., an Israeli company controlled by the Reporting Person.
- (b) The Reporting Person has sole power to vote or direct the vote and the sole power to dispose or direct the disposition of all of the Ordinary Shares disclosed in Item 5(a) above.
