(1) JEN I, L.P. transferred 28,975 shares of Issuer's common stock and JEN Residential L.P. transferred 19,318 shares of Issuer's common stock to persons and entities involved in a prior transaction involving the JEN Partners, L.L.C. and Issuer. The transfer of shares was for no consideration.

(2) The Reporting Person is the sole managing member of JEN Partners, L.L.C., which is the general partner of both JEN I, L.P., which directly holds 601,368 shares of Issuer's common stock, and JEN Residential L.P., which directly holds 400,911 shares of Issuer's common stock. By virtue of the Reporting Person's position as sole managing member of JEN Partners, L.L.C., the Reporting Person may be deemed to be the beneficial owner of 1,002,279 shares of Issuer's common stock. The Reporting Person disclaims beneficial ownership of the reported securities except of his pecuniary interest thereon.
