Explanation of Responses:

- (1) Reflects the issuance of CUB common stock upon vesting of restricted stock units ("RSUs"). Each RSU granted at that time represented a contingent right to receive one share of CUB stock.

This is the first of 4 vesting installments of RSU's granted to the Reporting Person on November 14, 2016. The remaining 2850 shares
- (8) from such grant shall vest in 3 equal installments on October 1, 2018, 2019 and 2020, subject to the Reporting Person's continuous service through each application vesting date.
