- (1) There is no reportable change since the last filing. This is a reiteration of holdings only.  
The reporting person elected to defer the receipt of common stock until the termination of his service as a member of the HP's Board of Directors. The 14,273.9165 shares being reported includes 48.4720 dividends at \$33.61 per share deferred on 04/02/14, and a de minimus adjustment of 0.4374 due to fractional rounding of shares.
- (3) Each restricted stock unit represents a contingent right to receive one share of HP common stock.  
As previously reported, on 04/22/13 the reporting person was granted 13,918 restricted stock units ("RSUs"), all of which cliff vested on 04/22/14. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The
- (4) number of derivative securities beneficially owned immediately prior to the transaction being reported includes 60.1277 dividend equivalent rights at \$33.61 per RSU credited to the reporting person's account on 04/02/14.
