- (1) Mr. Stougaard was granted an aggregate of 92,105 restricted stock units, subject to the satisfaction of vesting requirements over a five-year period. Mr. Stougaard has only the rights of an unsecured creditor in the restricted stock units, and no rights as a stockholder of Sunstone Hotel Investors, L.L.C. until the restricted stock units vest.
- (2) On October 26, 2004, 23,026 restricted stock units vested, and 8,163 shares of Common Stock were withheld to satisfy tax withholding obligations.
