- (1) Direct total report on original Form 4 filed April 4, 2005 was 7,611, but should have been 14,962. Direct total reported prior to the April 4 Form 4 filing was 7,351. On January 21, 2005, the common stock of NCR Corporation split 2-for-1, with the result that the previously reported 7,351 shares increased to 14,702 shares. Adding the 260 shares granted March 31 to the 14,702 previous balance, the reporting person's balance is now 14,962.
